FUNERAL DISCLOSURES

FUNERAL GOODS & SERVICES: CFCS will provide the selected funeral plan and items as shown in this Agreement, unless factors beyond its control prevent it from doing so. CFCS will furnish the services and brands associated with the funeral plan and items selected or, if those are unavailable, goods and services of equal quality, value, and workmanship. The funeral portion of this Agreement is revocable unless the Purchaser indicates otherwise by signing in the space provided in this Agreement.

AMOUNT TO BE TRUSTED / EARNED ANNUAL INCOME: Of the Funeral Plan Total, CFCS will place amounts contributed by the Purchaser in a trust with ClearPoint Federal Bank & Trust ("ClearPoint" or the "Trustee"). The deposit shall be made within thirty (30) days. The earned annual income on the funds received under this Agreement and placed in trust will be credited to the Purchaser's account. Administrative expenses, if charged, will be paid from income only.

GUARANTEED GOODS & SERVICES: If funeral goods and services are designated as being GUARANTEED, CFCS agrees to accept the funds available in the Trust as full payment for the funeral goods and services selected in this Agreement, even if the retail price for those items or services at the time of need is greater than the funds available. CFCS is not entitled to receive any trust funds attributable to Non-Guaranteed items or services, including any growth attributable pro rata to such Non-Guaranteed items or services to cover the retail price of Guaranteed items and services.

NON-GUARANTEED GOODS & SERVICES: If funeral services or items are NON-GUARANTEED, then CFCS does not guarantee the price of those items. Instead, Purchaser will pay an amount equal to the cost of the goods and services selected in this Agreement based on the retail price of the selected goods and services at the time of need. CFCS has no way of predicting what the prices will be at the time of need, and so the amounts are estimations, and are subject to change in the future. Any funds paid to the Trust are only a deposit to be applied, together with accrued income less any fees, taxes and income distributions, toward the final price of the goods and services contracted for. Any additional cost for Non-Guaranteed items or services will be charged to Purchaser, Purchaser's survivors, or Purchaser's estate, after the services are provided. Any additional items chosen which are not specifically included in this Agreement will be paid for when the funeral goods and services are provided.

CANCELLATION AFTER THIRTY (30) DAYS: Any cancellation of this Agreement by Purchaser after thirty (30) days, or change of Funeral Provider, may entitle CFCS to recover a cancellation fee not to exceed ten percent (10%) of the paid-in corpus which is chargeable against earned income only. No such cancellation fee will be charged if CFCS is unable to perform in accordance with the terms of this Agreement. If this Agreement is so canceled, the Purchaser will receive the corpus of the trust within fifteen (15) days from CFCS receipt of written cancellation pursuant to applicable state law. No cancellation fee may be charged if CFCS is unable to perform substantially according to the terms of this Agreement.

RELOCATION: If the Purchaser changes his/her primary residence to a location outside of this state, it may be necessary to execute a new Agreement. If the Irrevocable Option has been selected, any change of Funeral Provider or the execution of a new Agreement may not alter the irrevocable nature of this Agreement, and any waiver of the Purchaser's rights to cancel the trust may remain in effect, pursuant to applicable state law.

CHANGE OF FUNERAL PROVIDER: If funeral goods and services are provided by someone other than CFCS, the Trustee shall have the right to pay the amount in the Trust to the party that provided the services in accordance with the terms of the Master Trust. Any guarantees for funeral goods and services may not apply in such event.

CHANGE OF BENEFICIARY: At any time before the death of the Beneficiary, Purchaser may designate a new Beneficiary for whom the agreed upon goods and services will be provided by providing written notice to CFCS.

DEFAULT BY PURCHASER: If payments become more than thirty (30) calendar days in arrears, any guarantees regarding this Agreement shall lapse. In such event, the Purchaser shall be responsible for paying any additional amount owed.

FAILURE OF PERFORMANCE: If for any reason, CFCS cannot or does not perform the goods and services stated in this Agreement after the death of the Beneficiary and a request to CFCS to provide the goods and services, and the Purchaser, family member, or next of kin provides such goods or services on behalf of the Beneficiary through alternative means, then Purchaser or the family member or next of kin who arranged for the goods or services shall be entitled, after providing an affidavit to the Trustee, to receive the amount of money on deposit for this Agreement.

EXONERATION: ClearPoint shall not be responsible for the provision of goods and services by CFCS. Delivery by ClearPoint of all assets held by ClearPoint hereunder to CFCS in accordance with this Agreement shall relieve ClearPoint of liability under its Master Trust and this Agreement. Purchaser, for him/herself and for his/her beneficiaries, heirs, personal representatives and assigns, agrees that no claim or demand of any kind or nature whatsoever shall be made upon or asserted against ClearPoint, resulting from or arising out of any act or omission of the Funeral Provider.

LIMIT ON DAMAGES: CFCS will not be liable for special or consequential damages. A claim based on anything CFCS provides or does under this Agreement shall not exceed the price charged for a particular item involved in the claim.

DISBURSEMENT: CFCS is required to furnish to Purchaser, within fifteen (15) days of receiving a written request, a written statement of all contributions made. Any assets held by ClearPoint as part of the Trust shall be delivered to CFCS within thirty (30) days after CFCS provides a certified copy of the death certificate and CFCS and a witness have certified in writing that CFCS has provided the goods and services under this Agreement. If Purchaser dies or becomes incompetent or incapacitated, his/her rights under this Agreement may be exercised by his/her legal representative or other person designated in the Agreement.

ACKNOWLEDGMENT: CFCS may request that certain taxes be paid from the Trust earnings. This may reduce the funds available to Purchaser to pay for the funeral. By executing this Agreement, Purchaser acknowledges and certifies that: (a) he/she has read this Agreement; (b) the social security number and other personal information provided herein is true and correct as of the date hereof; (c) he/she is not subject to any mandatory withholding of income requirement imposed by the Internal Revenue Service; (d) he/she is aware of the Trustee's obligation to report any income earned on account of this trust to the Internal Revenue Service and appropriate state taxing authorities; (e) he/she was given a current General Price List prior to discussing, or upon beginning discussion of, funeral arrangements or the selection of any funeral goods or services; and (f) he/she was shown a Casket Price List and an Outer Burial Container Price List prior to discussion, or upon beginning discussion of, caskets or outer burial containers. By signing this Agreement CFCS is creating a funeral planning trust for the benefit of Purchaser. Such Trust is governed solely by the terms of the ClearPoint Federal Bank & Trust Funeral Planning Master Trust Agreement, all the terms of which are incorporated herein by reference and made a part hereof. This Agreement is not accepted by ClearPoint until it is received in ClearPoint's home office located in Batesville, Indiana. The Trustee is permitted to receive reasonable compensation in accordance with the Master Trust. Upon distribution of all assets held in the Trust, this Agreement shall terminate, the Trust shall terminate, and the parties shall have no further duties or obligations under this Agreement or the Master Trust.

NOTICE TO APPLICANTS OF SSI/SSP BENEFITS: If you are considering the purchase of an irrevocable trust to fund burial expenses and are also applying for SSI/SSP benefits, please be advised that the SSI/SSP program places limits on irrevocable burial trusts that are more restrictive than those placed by Medi-Cal, according to guidelines in effect in California as of December 2017. These limits may affect your eligibility for SSI/SSP benefits. CEMETERY DISCLOSURES

OWNERSHIP OF BURIAL RIGHTS: All rights herein are granted to Purchaser, who shall retain all rights of interment. The only exception will be where the Purchaser assigns all rights of interment to a named Owner, by indicating that assignment of rights on the first page of this agreement, under "Assignment of Burial Right Ownership", in which case all rights of interment are irrevocably transferred to the named Owner. In the event that a third party (not the Purchaser or Owner listed in this Agreement) pays any of the amounts due under this Agreement, the parties specifically intend that such third party shall not gain any rights of interment under this Agreement. Grave, crypt or niche purchases under this Agreement are for interment or entombment rights only. This Agreement does not grant any real property ownership, as such ownership is expressly retained by CFCS. Burial locations are intended for interment/entombment only. In no case shall Purchaser, or an assigned Owner, have any right to sell, exchange, or in any manner dispose of a grave, crypt or niche, except as provided herein. No rights of interment or entombment will be conferred upon Purchaser or his/her assigned Owner until the burial rights portion of this Agreement is paid in full. Once paid in full, Purchaser or the assigned Owner is entitled to inter of entomb the designated number of human remains, in the designated interment spaces, as permitted by CFCS and specified in this Agreement.

CANCELLATION WITHIN THIRTY (30) DAYS: If the Purchaser wishes to cancel this Agreement, he/she must send a request in writing to the CFCS location identified on the first page. The Purchaser must provide this written request to CFCS within thirty (30) days of the date this Agreement is fully executed. Upon receipt of a timely request for cancellation, CFCS will refund all monies paid by Purchaser in connection with this Agreement. After thirty (30) days, this Agreement may no longer be canceled.

Thank you for helping to help keep Holy Sepulchre a safe and sacred place to care for all our loved ones. Our regulations exist and are enforced to allow us to manage our cemetery properly and to respect the experience of all visiting families to our beautiful location.

1. **Fresh Cut & Artificial Flowers are permitted.** No more than two arrangements per adult grave are allowed. Additional arrangements will be removed. The cemetery is not responsible for any missing or damaged arrangements.
2. **Glass & Breakable Items are not permitted.** Cemetery staff will remove and discard all glass objects, vases, ceramic pottery, statuary, solar lights, candle holders, toys, pinwheels, balloons and other breakable or hazard items. Alcoholic containers of any kind are not permitted and will be removed.
3. **Excessive or profane decorations that encroach on neighboring locations are not allowed** and will be removed by grounds staff without notice and discarded.
4. **Mausoleums** – it is not permitted to leave any decoration on floor. Cemetery staff will remove and discard any item affixed to the front of a crypt or niche without notice. Fresh flowers are not allowed in mausoleums.
5. **Holiday and special event decorations will be removed within 30 days** after the event and discarded.
6. **Oakland Diocese, CFCS and its staff or any cemetery service providers are not responsible for damaged, lost, removed or missing decorations.**
7. CFCS reserves all rights to **tree, shrub, grass and plant planting, management and trimming. No other plants, grass or trees may be added** or removed to or from the cemetery.
8. **Please report any repairs** to cemetery grounds to the cemetery front office during business hours.
9. **Family celebrations and social gatherings are allowed under the following conditions.** Respect and safety for all neighboring families is required. Gatherings with 5 or more attendees must register with the front office in advance. No alcohol is allowed on the property at any time. Tents, canopies, tables, barbecues loud music, sporting equipment, campfires and coolers are not allowed at any gravesite without advanced notice given to office. Parties and unruly gatherings will be asked to leave the property.
10. **Speed limit.** A 10 mile per hour speed limit is enforced on the property.
11. **Visitors are allowed on cemetery property only during business hours.** Cemetery and security staff may advise of closing times and advise to visitors to vacate premises within 15 minutes of closing time. No visitors are allowed outside of opening hours at any part of the property.
