- 1 Traumatic subarachnoid haemorrhage
- 2 severe brain oedema
- 3 brain death
- 4 Cardiac arrest

Ms KIM HYUN DEOK 59 years old female American was admitted to our Accident and emergency department on the 31<sup>st</sup> of July 2010 in deep coma at 19:57 hours. She was brought in an ambulance referred from Kabgayi hospital. She was reportedly involved in a car accident as a passenger 3 hours before.

On arrival she was found to be in deep coma, intubated and hand bag ventilated.

Her vital signs on arrival were;

BP 111/81 mmHg, PR 105 bpm, Temperature 36<sup>0</sup>C, SPO<sub>2</sub> 96%

GCS 5/10 +ETT

Pupils Bilateral midriasis size 6mm none reacting

Was started on 100 ml of 20% Mannitol

She had extensive echymoses marked on the back, left leg and in the left iliac fossa she also had a bleeding scalp wound.

She had severe pallor of mucous membranes

CT scan of the brain revealed severe subarachnoid haemorrhage and contusion in the basal of the frontal lobe and intracerebral oedema.

On arrival to ICU: At 21:00 hours

Was in deep coma GCS 5/10 + ETT with low blood pressure 53/43 mmHG

Investigations revealed low haemoglobin 7.6g/dl, metabolic acidosis, deranged coagulation profile with INR 2, PTT patient 52.9' (control 34')

**Management:**

She was ventilated with PRVC SIMV at VT 500, Psv 10 PEEP 5 FIO<sub>2</sub> 60-100%

Her blood pressure was supported by fluids and Dopamine with initial good response

She was transfused with packed cells and fresh frozen plasma

Vision: KFH, K will be a Centre of Excellence in health services provision and clinical education in Africa

Her condition however deteriorated progressively and she went into complete non responsiveness the following day.

Supportive treatment was continued but she was non responsive to vasopressors and inotropic support.

She developed severe bradycardia and went into asystole on 3<sup>rd</sup> August 2010 at 15:00 hours.
